## Jordan English

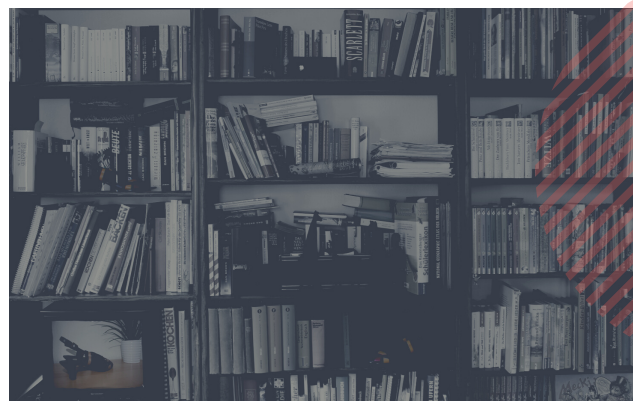
### Biography
